

## **RISK, RELEASE AND INDEMNIFICATION**

In consideration of imparting training and the services to be provided by Guardian Giripremi Institute of Mountaineering and/or Giripremi Adventure Foundation, its officers, employees, agents, volunteers, participants and all other persons or entities associated with or acting in any capacity on its behalf (collectively referred to as "GGIM" and "GAF").

assigns, personal representatives and estate and for all  
members of my family - as follows:

1) I understand and acknowledge that trekking, rock climbing, mountaineering, water/air adventure activities and any such adventure activities as run by GGIM and/or GAF have known and unanticipated risks that may result in physical and/or emotional trauma, injury, paralysis, death or damage to my minor son/ daughter, to my property and/or to third parties.

2) I expressly agree, accept and assume to myself all of the risks, dangers and hazards that exist in the activities my minor son/ daughter may be performing in and out of the campus of GGIM and/or GAF.

3) That participation of my minor son/ daughter in the said activities is purely voluntary and I have elected to participate in the same at my own risk, costs and consequences.

4) That I hereby release, discharge and indemnify and hold harmless GGIM and/or GAF from any and all kinds of actions, claims, demands or causes of action which may be connected with my minor son's/daughter's participation in the activities and/or from my minor son's/ daughter's use of GGIM and/or GAF's equipment/s or facilities including any such claims which allege negligence/acts or omissions of GGIM and/or GAF.

5) That I also indemnify and hold harmless GGIM and/or GAF for any costs, consequences, fees, expenses that shall be required to enforce any agreement, it's contents and its effects.

6) That I shall also ensure adequate insurance to cover any injuries or/and damages that my minor son/ daughter may cause or suffer while participating in the activities and shall keep indemnified GGIM and/or GAF in that regard. That any extra expenses, damages, costs beyond such insurance cover/s, shall be borne and paid by me and I shall keep indemnified GGIM and/or GAF there from also.

7) That I acknowledge, give consent and understand that GGIM and/or GAF may contract with independent contractors/service providers/outsourcing agencies/authorities etc. to provide various allied services on the course or activity in which my minor son/ daughter may participate, including transportation, lodging, boarding, travel services and guide services etc. AND upon which GGIM and/or GAF may not have control and that GGIM and/or GAF accepts no responsibilities for the actions/inactions of any such independent contractors/agencies/authorities involved in providing such services on my minor son's daughter's trips, activities, training etc.

8) That the laws of the State of Maharashtra shall be applicable to all the activities in which my minor son/daughter may participate with the GGIM and/or GAF and also to the enforcement of any agreements etc. with GGIM and/or GAF and I consent to the jurisdiction and venue of the courts at Pune, Maharashtra.

9) I also agree and shall ask my minor son/daughter to abide by the rules, regulations, bye-laws, instructions, directions given by the GGIM and/or GAF and its officers either oral or in writing AND I agree that upon either failing to obey them or disregarding them may result in my minor son's/ daughter's expulsion from activity/course without any prior notice AND that in certain cases, I will not get even a refund for the activity/course fee and associated fees.

10) I also vouch/certify that my minor son/ daughter is physically and mentally fit for such a course/activity and his/her medical authority has given explicit permission to participate in the course/activity my minor son/daughter is enrolling. That I have not concealed any past/present history of illness of my minor son/ daughter to his/her medical authority or to GGIM and/or GAF. I also confirm to submit the physical and mental fitness certificate from my minor son's/ daughter's medical authority for any future activities that I may participate in with GAF and/or GGIM.

11) I acknowledge that I have been informed and am fully aware that photographs and videos of my ward may be captured during the course of activities.

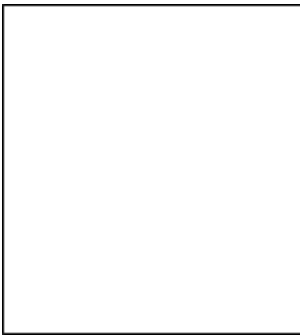
I hereby grant my full consent for such media to be used for marketing, promotional, and educational purposes across various platforms, without any limitation regarding geography or duration.

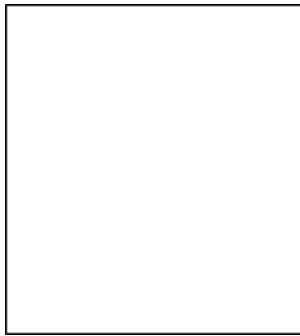
